



**Visualize Your Space Contest
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS CONTEST IS OPEN TO LEGAL U.S. RESIDENTS CURRENTLY RESIDING IN THE 50 UNITED STATES AND WASHINGTON, D.C., 18 YEARS OF AGE OR OLDER AS OF 1/1/16. CONTEST PERIOD BEGINS AT 12:00:01 AM PT ON 3/1/2017 AND ENDS AT 11:59:59 PM PT ON 4/12/2017. VOID OUTSIDE THE U.S. AND WHERE PROHIBITED BY LAW. SUBJECT TO ALL FEDERAL, STATE AND LOCAL LAWS, REGULATIONS AND ORDINANCES.

ELIGIBILITY: The Eldorado Stone Visualize Your Space Contest (“Contest”) is open and awards will only be granted to legal U.S. residents currently residing in the United States and Washington, D.C., 18 years of age or older. Eligibility is limited to legal U.S. residents. Employees of Eldorado Stone Operations LLC (“Sponsor”), or any of its parent companies, subsidiaries, affiliates, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers, webmasters, and members of their immediate families (spouses, parents, children, siblings and their spouses, regardless of where they live) and those living in the same household are not eligible to enter or win. Sponsor reserves the right to conduct a background check on any potential grand prize winner and reserves the right in its sole discretion to disqualify any person based on such background check if Sponsor determines in its sole discretion that awarding the prize to such potential grand prize winner might reflect negatively on Sponsor. TIMING: The Contest period (“Contest Period”) begins at 12:00:01 AM PT on 3/1/2017 and ends at 11:59:59 PM PT on 4/12/2017. Sponsor’s computer system is the official time-keeping device for the Contest.

HOW TO ENTER: During the Contest Period, you may enter the Contest in the following way:

If you have an interior space within your residence or other property within which you would like to install Eldorado Stone product, then you may enter the Contest by visiting the Eldorado Stone Website and completing the online entry form and providing (1) your name, address, email address, phone number and the address of your residence or other property where you would like to install Eldorado Stone products; and (2) uploading at least one photo through the Visualize Your Space tool of the interior or exterior space at your residence or other property where you would like to install Eldorado Stone products.

Incomplete entries will not be accepted and will be automatically rejected. No mass entries or mechanically reproduced entries will be accepted. Only (1) one entry per household will be accepted. Additional entries will disqualify the submitting entrant from this Contest and eligibility for a prize. All eligible entries will be entered in the prize evaluation. When you enter the Contest at the Eldorado Stone Website, you will be asked to consent to receive promotional e-mails and reminders from the Sponsor. You can opt-out of receiving offers from Sponsor at any time and opting-in does not impact your chances of winning. See Sponsor's privacy policy at www.eldoradostone.com for complete terms. Consenting to receive such e-mails is optional and does not have to be agreed to in order to be eligible to enter the Contest and does not improve your chances of winning. GRAND PRIZE/ ODDS OF WINNING: One (1) grand prize winner will be awarded a maximum of \$5,000 (calculated at MSRP pricing) of their choice of Eldorado Stone products by Sponsor to use at the winner's sole discretion. All taxes, fees, and surcharges on any prize and all other expenses not explicitly included above in the description of such prize are the sole responsibility of the winner. All federal, state, and local taxes on prize are winner's responsibility. The grand prize winner will be issued a 1099 tax form for the ARV of the prize. Sponsor will select on or around 4/21/17, in its sole and exclusive discretion, 6 finalists from all eligible entries received during the Contest Period. The criteria to be used by Sponsor in selection of the finalists shall solely be in the discretion of Sponsor and its internal panel of judges. Finalist entries will be published to the Eldorado Stone Facebook page (Facebook.com/eldoradostone) where public voting will determine the Grand Prize Winner. The criteria to be used in the selection of a potential Grand Prize winner will be subject to the amount of Likes the official entry photo receives during the public voting period which concludes on 5/5/17. The potential winner will be initially notified by mail, email or phone and will be sent an official notice, which will include an Affidavit of Eligibility, Liability & Publicity Release. The potential grand prize winner will be required to sign and return to Sponsor, the Affidavit of Eligibility, Liability & Publicity Release in order to claim his/her prize. Should the Contest be terminated prior to the stated expiration date, notice will be posted on the ES Website.
